

NOTICE REGARDING COVID-19 REQUIREMENTS FOR ALL PERSONS ENTERING RED MILE GROUNDS

The following is a list of precautions and procedures that will be in place this year for all persons entering Red Mile grounds to enhance the safety and reduce the spread of COVID-19 all. Note that this list is not exhaustive, is subject to change as conditions require, and that you should periodically access our website at (Redmileky.com) or contact the race office for updates or questions. Any persons who do not comply with requirements in effect at the time will be subject to disciplinary action, including expulsion from the grounds for the duration of the 2020 race meet.

Access Restrictions:

No media or fans will be allowed on the track until further notice.

No guests, no exceptions.

No congregating in any areas.

Social distancing at a minimum of 6 feet is required.

Race officials will be limited to their designated work spaces only.

Only KHRC licensed individuals with horses stabled at Red Mile and those who are responsible for the care of the horses (trainers, assistant trainers, grooms, drivers, veterinarians, farriers and feed vendors) are allowed in the stable area.

Wrist bands will be issued and required to be worn visibly by all persons cleared to enter the grounds.

Access Conditions:

Access points (entries/exits) to the stable area will be limited as determined by management.

All persons permitted to enter will be required to wear a facial mask covering the nose and mouth.

All persons eligible to enter will have their temperature taken. Those with temperatures above 100 degrees will be denied entry. (Details regarding process beyond this will be posted on the website and at the race office.) Temperatures will be required to be updated daily.

All persons must answer a series of questions related to their exposure to COVID-19 and their health status prior to entering.

As determined by conditions in the state at the time, COVID-19 testing may be required prior to entry and periodically afterward.

Changes to Normal Operations:

There will be numerous changes to operating procedures regarding training, racing, and in person interaction with the race office and administrative offices to reduce exposure and spread of COVID-19, as determined at the time. Since conditions and requirements are very fluid at this time, you should be aware of significant restrictions and seek updates regularly prior to arrival.

Acknowledgement:

I hereby confirm that I have read and understand the above notice regarding COVID-19 conditions at the Red Mile. I agree to cooperate with track management and KHRC officials regarding procedures and restrictions in place at the time of my attendance on any areas of the grounds. I understand lack of compliance may result in my expulsion from the grounds for the remainder of the race meet.

I attest that:

- * I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- * I have not traveled internationally within the last 14 days.
- * I have not traveled to a highly impacted area within the United States of America in the last 14 days.
- * I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- * I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- * I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I hereby release and agree to hold Red Mile Gaming and Racing (including Lexington Trots Breeders Assn, LLC, KRM Wagering, LLC, Red Mile, Inc, and Keeneland Association, Inc.) harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the facility, or that may otherwise arise in any way in connection with any activities I attend, participate in or services received from Red Mile Gaming and Racing. I understand that this release discharges Red Mile Gaming and Racing and all related entities listed above from any liability or claim that I, my heirs, or any personal representatives may have against them with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any activities I attend, participate in or services received from Red Mile Gaming and Racing. This liability waiver and release extends to all owners, directors, partners, and employees.
